



## **Contract Notice (CN) Dataset**

A Contract Notice is reported on AusTender as a result of a contract being awarded by an Australian Government agency at or above the relevant reporting threshold value of \$10,000 (inc. GST) for the majority of Australian Government entities. A Contract Notice displays details of the contract, including the contract period, value and the supplier.

Field name/variable name	Data type	Mandatory	Description
CN ID	Text	Yes	The unique system generated identifier by which the CN is identified. Where a contract amendment has been reported, the CN ID will be used with an amendment reference immediately following the CN ID. For example, CN1234-A1 would represent the first reported amendment to CN1234.
Agency	Text	Yes	The Agency responsible for the CN.
Contract Publish Date	Date - format DD/MMM/YYYY	Yes	This is the date the CN was published on AusTender.
Category	Text	Yes	AusTender uses a subset of the United Nations Standard Product and Services Classification (UNSPSC) codes for the classification of goods and services. The UNSPSC is selected by an entity when reporting a contract to reflect the primary purpose of the contract.
Contract Start Date	Date - format DD/MMM/YYYY	Yes	This is the start date identified in the contract. If there is no start date identified, it is the date the contract is signed. If there is no written contract it is the date of the first provision of the goods or services. The start and end date define the contract period.
Contract End Date	Date – format DD/MMM/YYYY	Yes	This is the end date that performance of the contract is expected to be completed. It does not take into account any options, extensions, renewals, or other mechanisms that may be exercised at a future date to extend the period of the contract. In cases where the end date is not specified, entities will need to estimate the expected date of receipt of the final instalment of goods or services. The start and end date define the contract period.

Contract Value	Numeric	Yes	The total (AUD) \$ value in Australian dollars, that is committed for the life of the contract including GST. The initial contract value should not include amendments, such as options, extensions, renewals, or other mechanisms, that may be exercised at a future date to increase the value of the contract. These are reflected in the contract value as amendments are made or options exercised. Where the contract spans several years, the total value is reported not the value on a per-annum basis.
Description	Text	Yes	A short, clear and relevant description of the contract.
Amendment Published Date	Date - format DD/MMM/YYYY	Yes	This is the date the contract amendment was reported on AusTender.
Amendment Start Date	Date - format DD/MMM/YYYY	Yes	This is the date the Amendment took effect. A material amendment will require an Amendment Start Date and must be on or after the Start Date of the parent contract notice.
Amendment Value	Numeric	No	The amount (AUD) the contract has been varied by. The amount must be over the current reporting threshold as specified in the Commonwealth Procurement Rules (CPRs) which is greater than or equal to \$10,000 AUD.
Amendment Reason	Text	Yes	The entity's reason explaining the amendment/s made to the contract notice.
Agency Reference ID	Numeric/Text	No	The agency's internal reference number for the contract. This number should be unique to the agency.
